L'attività clinica e di ricerca è focalizzata sulle complicanze cardiovascolari nell'infezione da HIV e della terapia antiretrovirale (HAART), e sulla valutazione di nuovi markers di adiposità viscerale (grasso epicardico) nell'obesità, nella sindrome metabolica e nella lipodistrofia HAART-associata. E' autore di 173 pubblicazioni su riviste nazionali ed internazionali e di 3 libri sulle manifestazioni cardiovascolari della malattia da HIV e sulla sindrome lipodistrofica associata alla terapia antiretrovirale (h index= 56 ; impact factor=12 50; n.83 nella lista di Top Italian Scientists).
